Chris Johnson Steps Down as Director of the Downtown Smithfield Development Corporation

After a long and successful 13 years, Chris Johnson has announced that he will be resigning as Executive Director of the Downtown Smithfield Development Corporation. Johnson was offered and has accepted the position of Economic Developer for Johnston County.

"It is with bittersweet emotions that I must announce today that I have submitted my resignation dated at the end of the day on September 20, 2013," states Johnson. "I have dearly loved every moment as your



Downtown Director and allowing me to be your public servant. The last 13 years have been such a joy, such a blessing and such an honor. There is nothing else in the world I would have rather done than to be your public servant in Smithfield. I greatly look forward to taking the same passion I hope was seen on the streets of Smithfield and applying them to Johnston County and the other municipalities I will serve." The Downtown Smithfield Development Corporation was first formed in 1984 and has had 4 other directors, with Johnson serving the longest tenure. Downtown Smithfield became a North Carolina statecertified Main Street Program in 1986. Over the past 27 years, Downtown Smithfield has been seen as a leader across the State with innovative business development incentives, assisting entrepreneurs with new construction and redevelopment projects, streetscape projects and improvements, and hosting community festivals and events.

During Johnson's time as Executive Director, those include: adoption of the Smithfield Master Plan, burying of the overhead utility lines, completion of the Market Street Streetscape Project, construction of the Neuse Riverwalk and Buffalo Creek Greenway, renovation of the Historic Hastings House, securing a permanent home for the Ava Gardner Museum, implementation of the Historic Brooklyn and North Smithfield Neighborhoods, implementation of the SHARP Grant program, expansion of the Ham & Yam Festival and countless other promotional events.

"In these 13 years, I really truly believe we not only met the goals set out by our board but succeeded (in) them," continued Johnson. "When you reach goals like that, you start looking for new things to do, or move on to something else that's going to challenge you. We have such great communities and a wonderful county. I will wake up every morning with the drive to make sure the rest of the world knows about it."

During the transition time, administrative assistant Sarah Edwards will assume the role of Interim Director until the Downtown Smithfield Development Corporation Board of Directors determines when and how the position will be filled.

"We are obviously saddened that Chris will no long be our Director, but we are more than confident in Sarah's abilities and leadership," states Barry Long, DSDC Board Chairman. "She has had opportunities in the past to take leadership positions in other communities in the State. We are very lucky she has remained with us."



SMITHFIELD Red Devil Football - There are still some spots remaining in the following age groups: Rookie(7-8) and Varsity (11-12). (Our JV (9-10) group is full - anyone interested in playing in this age group will be placed on a waiting list.) The child's age as of 8/1/13 determines playing age. Registration is \$40 for Smithfield Residents and \$80 for Non-Smithfield Residents. The Smithfield Red Devils play in the Johnston County Youth Football League. Games will be played in the fall on Saturdays, beginning in September. Practices begin mid-August.

SMITHFIELD Red Devil Cheerleading - The last day to register for Red Devil Cheerleading (girls ages of 5-12), is Friday, August 16. Registration is \$25 for Smithfield Residents and \$50 for Non-Smithfield Residents. Uniform cost should be around \$50 - which you purchase and keep. The only time we offer cheerleading is with our football program. The Smithfield Red Devils play in the Johnston County Youth Football League. Games will be played in the fall on Saturdays, beginning in September. Practices will begin mid-August.

SMITHFIELD Fall Soccer - The last day to register for Fall Soccer (for boys and girls between the ages of 5-12) is Friday, August 16. (The child's age as of 8/1/13 determines playing age.) Registration is \$35 for Smithfield Residents and \$70 for Non-Smithfield Residents. Games will be played in the fall, on weeknights, with an occasional Saturday game. Season will begin in September and wrap up around the end of October.

SMITHFIELD Volleyball - The last day to register for Fall Volleyball for girls (ages 9-14) is Friday, August 23. (The child's age as of 10/15/13 determines playing age.) Registration is \$35 for Smithfield Residents and \$70 for Non-Smithfield Residents. Games will be played in the fall, on weeknights, with an occasional Saturday game. Season will begin in September and wrap up around the end of October.

SMITHFIELD Men's Open League Softball - The last day to register for Mens Open League Softball is Friday, August 23. Registration is \$475 per team. (Maximum number of teams is 12.) All fees must be paid BEFORE the season begins, which will be after Labor Day.

SMITHFIELD Kinder Soccer - Register during August for Kinder Soccer (for boys and girls ages 3-4). Our Kinder Programs only meet 4 times, and will basically be an introduction to the sport of soccer. Actual play dates will be on Tuesdays and Thursdays, September 3, 5, 10 and 12. The cost is \$20 for Smithfield Residents and \$40 for Non-Smithfield Residents.
