FERC Approval of Planse for Purchase



Duke Energy Progress has received approval from the Federal Energy Regulatory Commission (FERC) to proceed with plans to purchase the North Carolina Eastern Municipal Power Agency's (NCEMPA) generating assets.

The FERC ruling, issued late yesterday, was based on a filing made by Duke Energy Progress on Oct. 10, 2014.

The ruling is an important milestone of the approximately \$1.2-billion transaction with NCEMPA, announced July 28, 2014.

NCEMPA currently maintains partial ownership interest in several Duke Energy Progress plants, including Brunswick Nuclear Plant Units 1 and 2 (Brunswick County), Mayo Plant (Person County), Roxboro Plant Unit 4 (Person County) and the Harris Nuclear Plant (Wake County).

The Power Agency's ownership interest in these plants represents approximately 700 megawatts of generating capacity. NCEMPA members' distribution assets are not part of the agreement, and will continue to be owned and maintained by those members.

"We are pleased to receive these approvals toward our goal of completing this purchase and providing positive benefits for both Duke Energy Progress customers and NCEMPA members," said Paul Newton, Duke Energy President - North Carolina. "We will now turn our attention to securing the state approvals necessary to close the transaction."

"This is a positive development for NCEMPA and is good news for eastern North Carolina," Electricities CEO Graham Edwards said. "We still face additional regulatory approvals before the transaction can be closed. We continue to be optimistic that we will finalize the agreement and secure a long-term, reliable and competitively-priced power supply for NCEMPA members."

Johnston County HS Bands to March as One

What is likely the county's largest marching band ever will parade through Smithfield and Clayton later this month.



More than 600 band members, representing Johnston County's eight high schools, are preparing to play in unison at the two towns' holiday parades on Dec. 11 and Dec. 13.

Clayton High band director John Pearson said it's the first time each band, in its entirety, will play as one.

"When we come around the corner, it's going to be pretty crazy," Pearson said.

"I don't think there's ever been a band with this many high-school students playing together in North Carolina."

The idea started about two years ago, Pearson said, when Smithfield-Selma High band director Brian Jones approached the other directors in the county about a way to get young people involved in music.

Jones said in today's society, children have few opportunities to see a traditional band with a wide range of instruments. One of them is during a parade.

"The thought was if we combined all of our schools together, someone would remember that for a long time - how massive that was," Jones said.

The directors tried to get the band going in 2013 but ultimately couldn't find time to practice during the holiday season, which was booked with other performances. This year, though, they're more committed and are using technology to make sure everyone's prepared.

The bands are practicing separately. And while instrumentalists are learning the same sheet music, color guard members are practicing with a shared online video.

Jones said using file-sharing technology via Google, the different bands can send videos back and forth, adding comments and edits along the way.

The bands will practice together on the afternoon of Thursday, Dec. 11, before the Smithfield Christmas Parade that evening. The band, which does not yet have a name, will play together again at the Clayton parade on Dec. 13. "We are really excited about putting all the kids together," Jones said. "They are all strong individually, but this is something people should remember for a long time."

Jones and Pearson said the ultimate goal for the large band is to enter a bid to play at the Rose Parade in Pasadena, Calif.

"Trying to put in a bid separately would be tough, but by combining forces and working together, it makes it more of a possibility," Jones said. "But we are hoping that everything goes smoothly, as we are doing it for the first time this year." (Courtesy www.smithfieldherald.com)

Town of Smithfield - Leaf Collection

Leaf Season is Here Again - What to do?

From the months of November - February the Town of Smithfield Public Works Department provides curbside leaf collection for its citizens. Crews are using large self-contained vacuum equipment to pick up loose leaves and pine straw. The Public Works Department urges residents to put their loose leaves and pine straw close to the curb line where vacuum equipment can reach it. Do not place debris in the street, ditch or gutter areas as this causes serious flooding issues during rain events. Keep all debris such as stones, dirt, branches and litter from leaves and straw. It is also important not to place your loose leaves and pine straw over water meters near fire hydrants, mailboxes and light poles. Please do not park vehicles near piles of leaves on scheduled days of pickup so crews can maneuver in and extract the debris with vacuum trucks. Citizens



are asked to be patient with the removal process and expect some delays during heavy times.

Other options for leaves

- Shred while mowing your lawn in small amounts. The chopped up leaves will decompose into natural nutrients for your grass.
- Use the leaves as mulching material around trees, shrubs, landscapes and natural areas.
- Using bagging devices on your mower collect the leaves mixed with grass and place them in compost bins. Till the organic matter in your vegetable gardens and spring planting projects.

What not to do with your leaves

- Raking or blowing your leaves into the street, ditch and gutter areas. This method causes flooding issues by stopping up storm drain systems and driveway culverts.
- Burning your leaves inside the city limits. This method causes a host of problems such as fire hazards, respiratory problems and smoke issues inside neighboring residents.

Upcoming NC 210 Bridge Closures

Work Beginning January 5, 2015



The [N.C. Department of Transportation](#) has scheduled the closure of a section of N.C. 210 near Smithfield in Johnston County to begin on January 5, 2015, weather permitting. The closure will be in place for approximately eight months.

The closure is necessary for crews with S.T. Wooten Corp. of Wilson to replace two bridges over Swift Creek and the Swift Creek overflow. Both bridges were constructed in 1934 and are classified as Functionally Obsolete, which means they were built to design standards that are no longer in use. The new bridges will be built to modern design standards.

During the closure, through traffic on N.C. 210 will use [U.S. 70 Business/Market Street, Swift Creek Road and Cleveland Road](#) as a detour route around the closure. Local traffic will be able to use N.C. 210, but will not be able to cross the bridges. Message boards will be put in place near the intersection of N.C. 210 and U.S. 70 Business/Market Street, and at the intersection of N.C. 210 and Swift Creek Road to alert traffic of the upcoming closure.

These replacements are part of a \$10.4 million express design-build contract awarded to S.T. Wooten Corp. in 2013 to replace 12 bridges in Johnston County with new bridges by late 2015.

To date, nine of the 12 bridges in Johnston County have been replaced, including bridges on N.C. 96, Juniper Church Road, Benson-Hardee Road, Old Stage Road, Eldridge Road, Bizzell Grove Church Road, Old Beulah Road and two on Shoeheel Road. A bridge on Micro Road is currently under construction and is expected to open in mid-April, weather permitting.

Express design-build allows construction to go from zero to completion in less time for each bridge. This is more efficient than traditional design-build for less complex projects. The express design-build method allows the design, environmental permitting, utility relocation and construction to take place at the same time, under one contract. This method reduces overall construction time, helps the department avoid cost inflation, allows the contractor to make innovations that save taxpayers money, lessen environmental impact and alleviate driving delays for motorists.

Motorists are advised to use caution while traveling in the area and to expect delays. NCDOT reminds motorists to watch signs for construction information, stay alert and obey the posted speed limit.

Math Department Receives \$3,000 Grant



Smithfield Selma High School was selected to receive a grant in the amount of \$3,000 through the Classroom Technology grant program, sponsored by Wake Electric.

The Classroom Technology grant program strives to enhance innovative classroom projects that would not otherwise be funded. The proposed project, Spartans Soar, was written by math teacher, JoEllen Holder, to purchase Chromebooks specifically to be used in Math I classrooms.

As the Math I state exam is computer based, she wanted the students to have instant access to practice EOC (End of Course) style questions on a daily basis.

"The purchase of Chromebooks for my classroom will be a huge benefit to my students," said Holder. "My students take a computer based end-of-course test. They will now have daily access to Chromebooks in our classroom where they will be able to practice computer based math problems on a weekly basis."

According to Holder, the practice EOC questions are designed to mirror EOC questions the students will be tested on in June.

"I believe we will see a direct correlation with my students' test scores and their access to the EOC practice material," she said. "I will also have the ability to supplement lessons with more differentiation, meeting a student's needs for remediation by watching a tutorial video or acceleration by flipping the classroom and helping peers."

3. Phyllis Pearson of Petway Mills and Pearson, PA presented the FY 2013-2014 Audit to the Council.
4. Approved Zoning Text Amendment ZA-14-04 to the Town of Smithfield Unified Development Ordinance, Article 19-4, On-Premise Signs which will allow for properties located within commercial zoning districts with more than one street front one additional ground sign.
