It is that time of year to begin planning for the upcoming **ADULT PICKLEBALL LEAGUE**. Code of Conduct

The intent of this policy is to ensure, to the best of our ability, that a safe, wholesome and encouraging environment be provided for all who are involved in the activity, whether they be a coach, player, spectator, or official.

According to the "Code of Ordinances of the Town of Smithfield, Section 12-97., "No Person shall conduct himself in a disorderly or obscene manner or commit any nuisance upon the grounds of any park or recreation area."

Based on this ordinance, the Town of Smithfield's Parks and Recreation Department and the Smithfield Parks and Recreation Advisory Committee have adopted the following policy to deter such

be suspended, or banned from all further Smithfield Parks and Recreation activities, programs and/or events. Any spectator, participant or coach who conducts themselves in a disorderly manner as described above may This type of unacceptable behavior includes, but is not limited to, foul, abusive or profane language and/or gestures demonstrated toward other persons in attendance.

a special hearing will be scheduled with the Parks and Recreation Advisory Committee to decide what action, If in the event of such an occurrence, a formal complaint is filed with the Parks and Recreation Department, if any, shall be taken. Options will include, but not be limited to, temporary suspension, expulsion from all

future programs, or legal action.



Adult Pickleball Men's & Women's Doubles Leagues

Rules and Regulations

- Registration for the league will only need to be completed by one individual.
- The team roster must be completely filled out and submitted to the Athletic Programs
 Supervisor by the first night of regular season games.
- A team's roster must have a minimum of four players with a maximum of eight players.
- Any changes to the roster made after the second week of the regular season must be approved by the Athletic Programs Supervisor.
- A player on the roster must play in at least four regular season matches in order to be eligible for the post-season tournament.
- Minimum age to play is fifteen years old as of the first regular season game.
- If a team is found playing an ineligible player, all matches that they have played in will be ruled a forfeit.
- Any coach or player that starts a fight or threatens an opponent player, spectator, or staff
 member will be suspended for the remainder of the season and may face further sanctions
 as deemed necessary.
- Games will be played to eleven points with the first team that reaches eleven being the winner. The first team to win two games to eleven points will win the match. Each match will be best two out of three ga
- The match format will be:
 - o Four players will play on game night



- The four players that play will be split into two pairs with each team playing simultaneously against the same opposing team that is split into two pairs.
- Once both matches are complete, the away team will rotate courts to play against the other pair from the team that they played in the previous match.
- o Matches are self-officiated. Players will call all lines on their side of the court.
- o All match results will be reported the Parks and Recreation staff that is present after the conclusion of play.
- Forfeit time is ten minutes after game time for the first match of the night. Match time is forfeit time for all other games.
- All teams must provide their own paddles and balls.
- All game balls must be named on the official list of approved balls posted on the USA Pickleball website.
- Paddle Specifications:
 - O The paddle's hitting surface shall not contain delamination, holes, cracks, rough textures, or indentations that break the paddle skin or surface, or any objects or features that allow a player to impart excessive spin on the ball.
 - O Reflection. The paddle's hitting surface shall not be adversely reflective, such that it has the potential to negatively affect the vision of opposing player(s).
 - O Size. The combined length and width, including any edge guard and butt cap, shall not exceed 24 inches (60.96 cm). The paddle length cannot exceed 17 inches (43.18 cm). There is no restriction on paddle thickness.
 - O There are no restrictions on paddle weight.
- The season will consist of eight weeks of regular season play with a double elimination tournament that will take place after the conclusion of the regular season.
- There will be two skill levels in both the men's and women's league. There will be a 1.0-2.5 (beginners) and a 2.75-3.50 (experienced)



- Matches will be played on Monday and Thursday evenings at the Smithfield Community
 Park Pickleball Courts. In the event of rainouts and forfeits, there may be games
 scheduled on other evenings at the discretion of the Athletic Programs Supervisor
- If a team is unable to play, they must notify the Parks and Recreation office by 4:00pm the day of the scheduled game.
- Teams with more than two forfeits in a season will not be eligible for the post-season tournament.
